MEMBERS ATTENDING THE PERTH VENUE WILL ALSO BE ELIGIBLE FOR THE REIMBURSEMENT

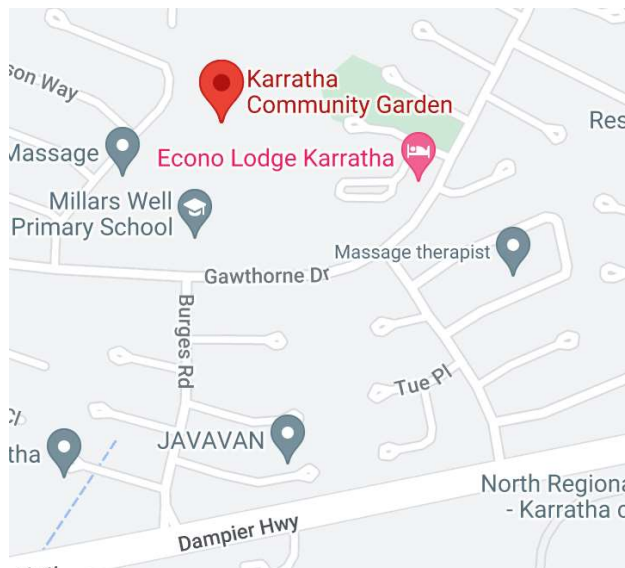
